## NOTES FOR CONTRIBUTORS

*JPD* is a refereed journal with a panel of international editorial advisors and readers. All articles are read by at least two referees and the editors. We welcome the following types of contributions at any time of the year, although we periodically send out a call for papers on specific topics.

**Critical themes and case analysis:** critical case studies and/or thematic discussion and analysis of topical peacebuilding and development themes -7,000 words maximum, including endnotes and bibliographic references. Significantly longer articles will be returned to authors to be shortened before being considered.

**Briefings:** 1) practice — training or intervention strategies, outcomes and impact; 2) policy review/ analysis; or 3) country situational updates — 2,000 words maximum.

**Book reviews:** critical assessments of new books that integrate peacebuilding and development concerns -1,500 words maximum.

**Resources:** notices of new books, reports, upcoming conferences and workshops, videos, E-communications and websites that link peacebuilding and development (150 words maximum); documents — declarations, communiqués and other relevant NGO or multilateral organisation statements (1,000 words maximum).

#### Presentation

- 1) Submit abstracts and articles to *JPD* prepared in word-processing software, preferably MS Word 6 or later, or saved in Rich Text Format. All submissions should come by e-mail to each of the following: abunimer@american.edu; erin.mccandless@gmail.com; maiagrace@yahoo.com; spike@mweb.co.zw and JPD@american.edu
- 2) Give full name, institutional affiliation of author(s), all contact details including e-mail and telephone number, and a brief biography. Provide an abstract of 150 words or less.
- 3) Use the Harvard system of referencing. References should be placed in the text where possible (author date: page). Notes should be limited to 10, and must be placed at the end of the article, as endnotes. Bibliographic references should be complete and in alphabetical order (author, date, title, place of publication, publisher).
- 4) Submit charts and graphs in eps or jpeg format.
